 - g) any changes made to the course content, facilities, equipment, training staff or other matters that may affect the delivery of the programme are reported to the approving MCA Office without delay.
- 2. Monitoring of the training programme by the MCA proves to be satisfactory.
- 3. Re-approval is carried out within five years of the approval date.
- 4. Mid-term audits will be carried out to ensure that all standards are being maintained.
- 5. All MCA audits and approvals may incur costs in line with the Fees Regulations in force at that time.
- Should the training establishment overleaf cease to trade then they must notify the MCA and return records of all certificates issued on behalf of the Agency to the UK Maritime Services branch. This allows continued authentication of certificates issued.
